We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2021-22 educational progress for the White Cloud High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2023-24 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2022-23. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was identified as a school that has not been given one of these labels.

White Cloud High School continues to strive to improve our educational processes and minimizing our educational gaps based on M-Step/SAT/P-SAT/NWEA MAPS testing data. We continue to focus on Mathematics, Reading, and Writing through our building initiatives such as homework supports, positive behavioral supports, special education programming, At-risk supports, dual enrollment, credit recovery, and virtual school programs.
