# What a Great Start to a Unique School Year!

Earlier in July, we created a White Cloud Back to School working group to review the governor's Roadmap to Return plan and to create our White Cloud Return to School Preparedness and Response Plan.

The focus areas of this work group were Safe Protocols, Operations, Instruction, and Mental & Social Emotional Health as students came back into our buildings or chose to learn remotely.

The one thing in this whole process that has been the only constant is change, and that we need to be adaptive and flexible.

Even with all the changes, our students, staff, families, and community have been very supportive and encouraging through the process. Our staff have been amazing in supporting our in-person and remote students.

Even prior to the year beginning, we made changes that students, staff, and families would have to adjust to what a typical day would look like at the elementary, junior high, or high school.

We adjusted the first week of school to ease student, staff, and family anxiety, which was widely appreciated by the community. Examples of other changes as the year began included wearing a mask, extended passing times, staggered start times, mask breaks, lunch and breakfast set-ups, one-to-one technology devices, class schedules, cleaning protocols, hand sanitizer stations, Google Classroom, and extracurriculars.

As we continue to navigate through this unprecedented year, WCPS will continue to communicate the national, state, or local-level changes as they come.

It has been so exciting seeing the students back in school. Even though it looks different, the enjoyment students have around their peers, playing sports, and being involved in school activities is refreshing.

I hope that you and your loved ones are well. The staff at WCPS are more committed than ever to do our work in a way that supports our students, families, and community.

It is that time again. Every so often, White Cloud Public Schools must ask voters to renew its operating millage.

The proposal on the ballot this November will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except a principal residence and other property exempted by law.

This is required for our school district to receive its state revenue per pupil foundation allowance and renews this millage, which will expire with the 2020 tax levy.

#### Just for clarification:

- This is a renewal of our operating millage and not a new millage.
- White Cloud Public Schools can only collect up to 18 mills.
- This operating millage supports our students, families, community, and school system.

# Student Health & Center Open For Business!

Yes, we are open!

White Cloud's child and adolescent health center, located in the middle school, is available, as usual, for all of your child's health care needs.

Make sure you have signed a consent form, available online (see the school district's "Preparedness Plan," appendix H, on their website) or pick one up in our office.

Center staff can evaluate and/or test your child for COVID-19 if he/she displays symptoms, i.e., fever above 100 F, dry or productive cough, shortness of breath, sore throat, body aches, diarrhea, headache, chest heaviness, profound fatigue, abdominal pain, or loss of sense of taste or smell.

Remember, we must have your permission to provide services for your child, including assessing or testing for COVID-19

How can you protect you and your children even more? By getting a flu shot!

Flu, most of the time, has the same symptoms as COVID-19. Now we are offering free flu shots for everyone, adults included! Just call us at (231) 689-3268.

When you call, we will tell you our extended hours and dates for these special flu clinics. Your child can receive this immunization at any time as long as we have your signed "Consent for Influenza Vaccine" form on file in his/her chart. These forms are available at our office; you or your child can pick one up or we can mail it to you.

Our health center staff care deeply about your child's health and well-being. In these uncertain times, being an adolescent can be even more stressful. Perhaps your child would like to talk to our behavioral health counselor about things that are happening and positive ways to cope with our ever-changing world.

Please do not hesitate to call us with any questions or concerns about your child. Together, we will get through this and be stronger than ever!

### Free School Meals Returns for 4th Year

White Cloud Public Schools is proud to announce that the WCPS School Nutrition Program will again participate in the federal program of Community Eligible Provision (CEP).

This great news means that all students enrolled at our schools are eligible to receive a healthy breakfast and lunch at school at no charge to your household each day of the 2020-2021 school year.

The prior three school years were considered successful. Each year we assess the prior year based on the food service program's continued financial stability, and our district's families filling out and returning the household information survey.

#### Important!

For this program to succeed and continue, the district is asking that each household fill out and sign the household information survey, which is needed for administrative purposes, not to determine eligibility.

This survey allows our school to benefit from various state and federal supplemental programs, such as Title IA, At-Risk (31a), Title IIA, E- Rate, and others. It is critical in determining the amount of money the school receives.

We are asking that you please complete and submit the survey as soon as possible. All information on the survey submitted is confidential. Remember, without your assistance, we cannot maximize available state and federal funds.

A copy of the survey is enclosed in the newsletter and is available in all schools.

#### **Breakfast and Lunch**

Breakfast and lunch look a little different this year as we tray and operate under the COVID-19 restrictions that the district must follow.

The food offerings are different, and last-minute changes are likely for all district menus as the Nutrition Services department copes with possible shortages in items from our distributors. We promise to do our best to keep any changes as minimal as possible.

Breakfast is served daily. Elementary breakfast is served in the classroom from 7:45 to 8:10 a.m. HS/JR high breakfast is served from 7:30 a.m. to 8:10 a.m. Breakfast is also available in all buildings for any student who arrives late. Please check into the office first.

#### **Virtual Student Meals**

Meals for students who attend school virtually are available daily for pick up in front of the junior high from 12:15 to 12:45 p.m. when school is in session.

These bagged meals include a breakfast and a lunch, and are for White Cloud-enrolled students only. Those picking up meals need to provide the students' name and ID number.

### Pest Management Advisory

ADVISORY TO ALL PARENTS Dear Parent/Guardian:

White Cloud Public Schools has adopted an Integrated Pest Management program. Inherent with this are the district's efforts to reduce pesticide use as much as possible. While it may occasionally be necessary to apply a pesticide, this program does not rely on routine pesticide applications to resolve problems. We use various techniques such as habitat alteration, sanitation, mechanical means, exclusion, etc. to prevent pest from becoming a problem.

As required by Michigan law, you will receive advanced notice of non-emergency application of a pesticide (insecticide, fungicide, or herbicide), other than bait or gel formulation, which is made to the school, school grounds, or buildings. This advance notice of a pesticide application will be given 48 hours before the application by the following two methods:

1. Posting at the primary entrances to your child's school. The entrances that will be posted are the main entrance and those that have a sidewalk that leads directly to a parking lot.

2. Posting in the common area located by the main office of the school.

Please note that notification is not given for use of sanitizers, germicides, disinfectants or anti-microbial cleaners. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but you will be promptly notified following any such application, via the two posting methods identified (above).

You may review the school's Integrated Pest Management program and records of any pesticide application upon request by contacting Ed Canning, Superintendent.

Parents or guardians of children attending the school are also entitled to receive the advance notice of a pesticide application, other than a bait or gel formulation, by first class United States mail postmarked at least 3 days before the application, if they so request. ### **Annual Notices**

### Family Educational Rights and Privacy Act (FERPA)

#### Rights Under FERPA

The federal law known as the Family Educational Rights and Privacy Act (FERPA) affords parents and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records. These rights are:

1. The right to inspect and review the student's education records within 30 days after the day the School District receives a request for access.

Parents or eligible students who wish to inspect their education records should submit to the school principal a written request that identifies the records they wish to inspect. The principal or designee will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.

2. The right to request the amendment of education records that the parent or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.

Parents or eligible students who wish to ask the School District to amend their child's or their education record should submit a written request to the school principal, clearly identifying the part of the record they want changed and specifying why they believe it should be changed. If the School District decides not to amend the record as requested, the school will notify the parent or eligible student of the decision and of their right to a hearing regarding the request for amendment. Additional information regarding hearing procedures will be provided to the parent or eligible student at the time they are notified of the right to a hearing.

3. The right to provide written consent before the School District discloses personally identifiable information (PII) from the student's education records, except to the extent that FERPA authorizes disclosure without consent.

One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. A designated school official with a legitimate educational interest includes a person employed by the School District as an administrator, teacher, or other person designated by the Board of Education. A school official also includes a liaison officer who, while not employed by the School District, may be granted access to student educational records (including video footage) at the direction and supervision of a school administrator. A school official also may include a contractor or consultant who, while not employed by the School District, performs an institutional service or function (such as design and maintenance of the School District's security camera

system) for which the school would otherwise use its own employees and who is under the direct control of the School District with respect to the use and maintenance of personally identifiable information from student education records.

4. The right to refuse to allow the disclosure of "directory information."

"Directory information" regarding a student may be released to any requesting person or party, in addition to the eligible student or his/her parent, without written consent. The Board of Education has defined "directory information" to include a student's:

- Name;
- Address and telephone number;
- Photograph;
- Birth date and place of birth;
- Participation in School District related programs and extracurricular activities;
- Academic awards and honors:
- Height and weight, if a member of an athletic team;
- · Honors and awards; and
- Dates of attendance and date of graduation.

In the event inconsistency exists between the Board of Education policy defining "directory information" and this annual notification, the policy prevails.

Each year, the Superintendent, or his/her designee, will provide public notice to students and parents of the School District's intent to make directory information available to students and parents. Common uses for students' directory information, which include, but are not limited to: recruiter requests, newsletter articles, newspaper articles, and athletic programs.

Eligible students and parents may refuse to allow the School District to disclose any or all of such directory information upon written notification to the School District within thirty (30) days after receipt of the School District's public notice. Parents may submit written notification to the building principal of their child's school and/or fill out the attached FERPA Opt-Out Form.

5. The right to file a complaint with the United States Department of Education concerning alleged failures by the School District to comply with the requirements of FERPA. The name and address of the Office that administers FERPA is:

#### **United States Armed Forces**

The School District is required to provide United States Armed Forces recruiters with at least the same access to student directory information as is provided to other entities offering educational or employment opportunities to those students as is permitted and/or required by law. "Armed forces of the United States" means the armed forces of the United States and their reserve components and the United States Coast Guard. An eligible student or the parent may submit a signed, written direction to the School District that the student's directory information not be accessible to United States Armed Forces recruiters. In such case, the information will not be disclosed.

#### Other Agencies or Institutions

As permitted by FERPA, the School District may forward education records, including disciplinary records, without student or parental consent, to other agencies or institutions in which the student seeks or intends to enroll or is already enrolled so long as the disclosure is for purposes related to the student's enrollment or transfer and upon receipt of a request for a student's school or education records.

#### **Compliance**

The School District will comply with a legitimate request for access to education records within a reasonable period of time, but not more than thirty (30) days after receiving the request or within a shorter period as may be applicable by law to students with disabilities. The requesting party may be charged a processing fee for the information.

#### **Notice of Asbestos in School Buildings**

White Cloud Public Schools has contracted to remove nearly all asbestos materials in our buildings. Asbestos in public areas was removed. Some asbestos in non-public areas was treated and secured rather than being removed in accordance with the Asbestos Hazard Emergency Act (AHERA). Each school building within the School District has been inspected for the presence of asbestos-containing materials as required by the Asbestos Hazard Emergency Response Act (AHERA). A copy of the Building Inspection and Management Plan for each building is available in the building's main office. The plans may be inspected by members of the public and by School District employees during normal business hours. A copy of the plan will be made available upon request for a nominal fee.

#### **Pesticides**

The Board of Education has adopted a policy to provide students and staff with an environment that is free of pests, pesticides, and harmful chemicals to the extent required by law. The Integrated Pest Management Program (IPM) includes routine inspections or surveys of all school facilities and various strategies to prevent pests from becoming a problem. Pesticides are used only as a last resort and parents will be notified prior to a pesticide application in a school building or on school grounds.

#### **Drug Free Environment/Protection**

The Board of Education recognizes that the misuse of drugs is a serious problem with legal, physical, and social implications for the entire school community. In accordance with the federal and state law, the Board establishes a "Drug-Free School Zone" that extends 1,000 feet from the boundary of any school property. The Board prohibits the use, possession, concealment, delivery, or distribution of any drug or any drugrelated paraphernalia, including alcohol and marijuana, at any time on School District property, within the Drug-Free Zone or at any School District-related event. Further, the Superintendent, or his/her designee, will take the necessary steps to ensure that an individual eighteen (18) years of age or older who knowingly delivers or distributes controlled substances so designated and prohibited by Michigan statute within the Drug-Free School Zone to another person is prosecuted to the fullest extent of the law.

#### **Discrimination and Harassment**

No person may be denied admission to any school in the School District, be denied the benefits of or be discriminated against in any curricular, extracurricular, or other School District program or activity based on the person's gender, religion, race, color, national origin or ancestry, age, disability, marital status, or any other legally protected characteristic. The Board of Education has adopted a Discrimination and Harassment Policy which prohibits all forms of illegal harassment and discrimination within the School District. Any person who believes that he/she has been the victim of discrimination may seek resolution of his/her complaint through the procedures that have been established by the School District. A person wishing to pursue a complaint may also contact the School District's Civil Rights Compliance Officer/Title IX Coordinator, Ed Canning, at 231-349-6591, canninge@whitecloud.net, or visit the Administration offices at 555 Wilcox Avenue, White Cloud, MI 49349.

### McKinney-Vento Homeless Assistance Act

The School District, in accordance with the McKinney-Vento Homeless Assistance Act, will ensure that homeless children and youth in transition have access to a free and appropriate public education, including preschool, and be given a full

opportunity to participate in state and District-wide assessments and accountability systems. A student may be considered eligible for services if he/she is presently living:

- In temporary shared housing, a shelter, or transitional living program;
- In a hotel/motel, campground, or similar situation due to lack of alternatives;
- At a bus station, park, car, or abandoned building; or
- In a temporary or transitional foster care placement.

The Board of Education has designated Melissa Bedell as the School District's Coordinator under the Homeless Assistance Act. ### Parental Inspection of Instructional Materials

Parents have the right to inspect, upon request, any instructional material used as part of the School District's educational curriculum. Parents will be provided access to instructional materials within a reasonable period of time after the request is received by the building principal. The term "instructional material" means instructional content that is provided to a student, regardless of its format, including printed and representational materials, audio-visual materials, and materials in electronic or digital formats (such as materials accessible through the Internet). The term does not include academic tests or assessments.

#### **School Property**

The Board acknowledges the need for a reasonable degree of in-school storage of student possessions and will provide storage places, including desks and lockers, for that purpose. Where lockers are provided, students may lock them against incursion by other students, but lockers remain School District property. Students do not have a reasonable expectation of privacy with respect to School District personnel or their designees in lockers or other in-school storage places provided by the School District.

#### Search and Seizure

The Board also authorizes the use of canines, trained in detecting the presence of drugs or devices. Canines are used to determine the presence of drugs in locker areas and other places where such substances may be concealed. Canine detection is usually conducted in collaboration with law enforcement authorities or other certified organizations and is

not used to search individual students without legally sufficient suspicion, a warrant or parental permission has been obtained.

School authorities are authorized to take reasonable steps to safeguard the safety and well-being of the students by, among other things, implementing the School District's Student Code of Conduct. Within the discharge of their responsibilities, School District personnel may search students, student property, and school property in the manner permitted by law.

#### **Special Education and Section 504**

The School District is required, by law, to locate, identify and evaluate all children with disabilities, including children with disabilities attending private schools located within the School District, as well as homeless children. The process of locating, identifying, and evaluating children with disabilities is known as child find.

Child find extends both to children who may be eligible for special education under the federal Individuals with Disabilities Education Act (IDEA) and those who may be eligible under Section 504 of the Rehabilitation Act of 1973 (Section 504).

If you believe your child may qualify under either the IDEA or Section 504, please contact the District's Director of Special Services.

#### Personal Curriculum

The Personal Curriculum (PC) is a Michigan Department of Education (MDE) endorsed process, permitting modification of specific credit requirements and/or content expectations based on the individual learning needs of a student. It is designed to serve students who want to accelerate or go beyond the Michigan Merit Curriculum (MMC) requirements and students who need to individualize learning requirements to meet the MMC requirements. For more information from MDE about personal curriculums, please go to https://www.michigan.gov/mde/0,1607,7-140-6530\_30334\_49879---,00.html.To the extent required by law, the School District will grant all requests for personal curriculums.

### Student Privacy and Parental Access to Information

Under the federal Protection of Pupil Rights Amendment (PPRA) and School District policy, no student will be required as a part of the school program or the School District's curriculum, without prior parental consent, to submit to or participate in any survey, analysis or evaluation that reveals information concerning:

- Political affiliations or beliefs of the student or his/her parents;
- Mental or psychological problems of the student or his/her family;
- Sexual behavior or attitudes;
- Illegal, anti-social, self-incriminating, or demeaning behavior:
- Critical appraisals of other individuals with whom students have close family relationships;
- Legally-recognized privileged and analogous relationships, such as those of lawyers, physicians, and ministers;
- Religious practices, affiliations, or beliefs of the student or his/her parents; or
- Income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such a program).

This requirement also applies to the collection, disclosure, or use of student information for marketing purposes ("marketing surveys"), and certain physical examinations and screenings.

Parents have the right to inspect, upon request, a survey or evaluation created by a third party before the survey/evaluation is administered or distributed by the school to the student. The parent will be given access to the survey/evaluation within a reasonable period of time after the request is received by the building principal.

Parents who believe their rights have been violated may file a complaint with:

#### Title I Funds: Parent Involvement

All the schools within White Cloud Public Schools receive Title I funding. In accordance with law, the Board of Education has adopted a parent involvement policy (also known as a parental and family engagement policy). The School District is committed to establishing and maintaining positive relationships with families and the community. To that end, the School District will provide a variety of opportunities for families and other members of the community to become involved in children's education.

Parents may request information regarding the professional qualifications of the student's classroom teachers in writing submitted to Ed Canning, Superintendent. The request may include:

- Whether the teacher has met Michigan qualification and licensing criteria for the grade levels and subject areas in which s/he provides instruction;
- Whether the teacher is teaching under emergency or other provisional status through which State qualification or licensing criteria have been waived;
- The teacher's baccalaureate degree(s), major, any other graduate certification or degree(s) held, and the field of discipline of the certification or degree; and
- Whether the student is provided services by a paraprofessional and, if so, the paraprofessional's qualifications.

### **Programs for English Language Learner Students**

Parents of limited English proficient (LEP) students participating in a language instruction program will be notified, no later than 30 days after the beginning of the school year, of the following:

- Placement and reason why their child was identified as LEP;
- The student's academic achievement level and level of English proficiency (including method of measurement);
- The methods used for language instruction;
- How the language program will meet the student's instructional needs;
- How the program will help the child to learn English and meet the academic standards required for promotion or graduation;
- The exit requirements for the language program; and
- An explanation of parental rights, including the parent's right to enroll or remove a child from the language instruction program.

#### **Wellness Policy**

The School District is committed to creating a school environment that enhances lifelong wellness practices. As required by law, the Board has adopted a Wellness Policy, which is periodically reviewed. The Board's policies and/or administrative regulations can be found at: www.whitecloud.net.

### Kickstart to Career Accounts Open for Deposits in December

Kickstart to Career Newaygo County savings accounts for local kindergartners will be open for deposits in December. In addition to an initial \$50 deposit from the Community Foundation, families and friends will be able to make deposits into their kindergartners' accounts to help them save for the future.

Created by Fremont Area Community Foundation in partnership with ChoiceOne Bank, Kickstart to Career Newaygo County will provide local students entering kindergarten from 2018 through 2027 with a deposit-only children's savings account. Students will be able to earn additional contributions each year through 12th grade. ChoiceOne Bank will also partner with local schools to provide financial education in classrooms.

Upon high school graduation, students can use their accounts to help pay for post-secondary education and career-related expenses such as tuition, books, and training.
